TERMS AND CONDITIONS OF TRADE

1. Definitions

- a) "Supplier" means Electralife Pty Ltd ACN: 623361768
- b) "Customer" means any person, body corporate or entity who engages the Supplier for the supply of goods and/or services.

2. Application of Conditions

These Conditions apply to all orders placed by the Customer with the Supplier. The Customer acknowledges that it will be bound by these Conditions which will form part of the Contract.

3. Governing Law & Submission to jurisdiction

All the Conditions and the Contracts will be governed by and interpreted in accordance with the laws of the State of Victoria. Australia.

4. Payment

Payment by the Customer is to be made within 7 days of receipt of the invoice. Time for payment is of the essence of the Contract. Where payments are overdue, the Supplier may, in addition to any other rights it may have, in its sole discretion, either cancel orders or suspend delivery of outstanding Goods and/ or Services. If the invoice price is not paid by the due date, then interest will accrue on that amount from the date of delivery of the Goods and/or Services until the price is paid in full. Interest will be paid at a rate of 12% per annum. Interest will accrue daily and be payable on demand.

5. Payment Default

If the Customer defaults in payment or breaches these Conditions then it will be liable for all costs incurred by the Supplier and will indemnify the Supplier against any loss, liability, charge, expense, outgoing or payment which the Supplier suffers, incurs or is liable for in respect of the recovery of monies owing by the Customer to the Supplier.

6. Price

The price of the goods and/or services will be in accordance with the written and/or oral quotation that will be provided to the Customer prior to the commencement of the works. However, in circumstances where more work is required than contemplated by the original quotation, the Supplier with provide the Customer with a new written and/or oral quotation and will not be bound by its original quotation. If the works are ongoing, the Supplier will invoice the Customer monthly for works completed. The Supplier may at its own discretion require upfront payment from the Customer prior to commencing or continuing works.

7. Title to Goods

Title to any & all Goods supplied by the Supplier will remain with the Supplier and no legal or equitable interest or property in the Goods whatsoever will pass to the Customer until the Customer has paid the full invoice price for all Goods supplied by the Supplier under all invoices. Until title passes the Customer must allow the Supplier full and free access to the Customer's premises where the Goods are located to retake possession of such Goods.

The Customer acknowledges and warrants that the Supplier has a security interest for the purposes of the Personal Property Securities Act 2009 (Cth) in the Goods and any proceeds until title passes to the Customer in accordance with this clause 7. The Customer must do anything reasonably required by the Supplier to enable the Supplier to register its security interest with the priority the Supplier requires and to maintain that registration. The security interest arising under this clause 7 attaches to the Goods when the Customer obtains possession of the Goods.

8. Hours

The Supplier will complete works between 7.30am and 3.30pm from Monday to Friday unless otherwise agreed between the Customer and the Supplier.

9. Force Majeure

The Customer acknowledges that the Supplier shall not be in breach of any agreement if it is unable to complete or is delayed in the delivery of the goods and/or services or any portion thereof by reason of fire, earthquake, labour dispute, act of God or public enemy, death, illness or incapacity or any local, state, federal, national or international law, governmental order or regulation or any other event beyond the Suppliers control (collectively, 'Force Majeure Event') and the Supplier will not be responsible for any consequential damages, losses, costs or additional charges caused thereby.

10. Intellectual Property

The supply of goods and/or services to the Customer does not constitute a transfer of any intellectual property rights in the goods and/or services or any part thereof. The Customer must not do anything inconsistent with or in infringement of such intellectual property rights. The Supplier does not warrant that the supply by it and the use by the Customer of the goods and/or services does not and will not infringe the intellectual property rights of any third party.
